### Part B. CV SUMMARY (*max. 5000 characters, including spaces*)

My CV shows a consolidated position as a researcher, with a number of successful grants, stays in leading research centres, and permanent contracts in international universities. After my PhD research (2013-2017, European PhD, Oriol-Urquijo predoctoral fellowship) at the Universidad Complutense de Madrid, I have held two post-doctoral research fellowships: a



post-doctoral stay (Oriol-Urquijo postdoctoral fellowship) at the University of Oxford (2018) and a postdoctoral fellowship (European Social Fund - YEI) at the Universidad Autónoma de Madrid (2017-2018). I have completed a three-month research stay at Torino (2016), a four-month stay at Madrid (2020-2021), and a two-and-a-half month stay at Oxford (2019). I also have won two international competitive contracts: a permanent contract as lecturer/researcher at Yachay Tech University in Ecuador (2018-2019) and a permanent contract as lecturer/researcher at Adolfo Ibáñez University (2020-2022). In short, I have 5 years of international experience in prestigious research centres in Spain, Italy, UK, Ecuador and Chile. Currently I hold a contract as lecturer/researcher (Profesor Ayudante Doctor) at Universidad Complutense de Madrid, Medicine Faculty (2022-present).

From the beginning of my research career, my main interest has been to understand the pervasive significance of technology and its effects on humanity. That is why my focus has been slowly shifting from Ortega's philosophy -which I have used to address issues such as ecology or transhumanism- to a broader focus on bioethics. In this regard, I consider my stays at the Uehiro Centre for Practical Ethics of the University of Oxford a very important milestone of my career, allowing me to improve my research skills, while participating in several research seminars and communications. Results from these stays were my two papers co-authored (as first author) with J. Savulescu, a prominent figure of current bioethics. My previous translation of N. Bostrom's influential work *Superintelligence* is also an outcome of my relationship with the university of Oxford.

I am author of 32 articles in refereed journals (28 single-authored, 4 as first author), 7 indexed in WoS, 21 indexed in Scopus (3 Q1, 5 Q2, 9 Q3 and 4 Q4), including prestigious international journals such as *Bioethics* and *Philosophia*, as well as national journals such as *Isegoría* or *Pensamiento*. My publications include 7 book chapters, 4 chapters in SPI Q1 publishers such as Dykinson (ranking 19) and Comares (ranking 17), as well as a book in CSIC publishing house (ranking 14) entitled *Ortega y la técnica*. I have presented my work at more than 30 international conferences and seminars, and have organised several international conferences and conference sessions. In May 2021 I received the accreditation as Profesor Contratado Doctor by the Agencia Nacional de Evaluación de la Calidad y Acreditación (ANECA).

I am currently the Lead Researcher (IP) of a FONDECYT Project (23.520.000 CLP) centered on the ethics of gene editing. I have made important contributions to the intersection between philosophy of technology, bioethics and applied ethics, consolidating me as an expert in these fields. I am also regularly contacted by international refereed journals to review articles on these topics. I have directed for four years (2014-2018) the Doctoral Students Association (*Tales*) of the Universidad Complutense de Madrid, organizing 3 International Congresses. I have directed two peer-reviewed journals: *Tales Magazine* (2012-2018) and *Lecturas de nuestro tiempo*, the latter being a personal project that started in 2016 and that I have been directing to this date. I have published 8 issues as director of these journals. All these achievements evidence my leadership capacity, as well as a sustained effort in the organisation of research and scientific networks.

Overall, my research has contributed to shed light into decisive issues of our present, as gene editing, transhumanism, ecology, identity and other topics within the field of applied ethics. My work on technology from the phenomenological-hermeneutical perspective of Ortega, combined with my current focus on the analytic tradition of bioethics, gives me an expertise on different philosophical methodologies and displays a unique research profile. For the next years, I seek to continue my research on applied ethics, particularly on the impact of new technologies as gene editing. I will therefore continue applying for national and international grants, improving my competence in teaching and researching, ultimately acquiring the necessary qualifications and skills to achieve a position as an established academic.
