Part B. FREE SUMMARY OF THE CURRICULUM Over more than four decades of academic work, my work at Spanish universities has been characterized above all by the revitalization of those traditions of German thought that were silenced for decades in our country. The thread here has been an exhaustive investigation of Max Weber's thought, from which I have explored the normative foundations of politics. This has also led me to leading figures in German thought of the last century: Carl Schmitt, Hans Blumenberg, Reinhart Koselleck's conceptual history and Helmuth Plessner's philosophical anthropology. Based on this constellation, without ever abandoning the Kantian origin of my training, my concern has focused on the possibility of articulating a republican conception of political power that would allow us to confront the excesses incurred by the modern political form; that is, the concept of sovereignty, of political theological origin, as opposed to the no less modern idea of a division of powers. The result of my research work has been 35 monographs, 11 book editions, 157 book chapters, 154 journal articles and 234 contributions to national and international conferences. I have supervised more than 40 doctoral theses, I have been the IP for 12 research projects, as well as for three Integrated Actions. I have organised more than 30 national and international congresses and seminars and have carried out research stays (22 months) in Germany, Italy, the USA and Colombia. The internationality of my work is also supported by my publications and conferences in various languages and countries, as well as by the creation of a network of colleagues of different nationalities, continents and disciplines that have allowed me to give shape, in the academic framework, to the concept of "Euro-American thought", to which I feel committed and which has been the guiding force behind my research in recent years. The result of this understanding of the tasks of social philosophy is the direction of the Euroamericana collection, which in a short time publishes

monographs by young and senior scholars from Europe and America and has a board of directors that brings together leading philosophers from around the world. Throughout my career, I have founded the magazine *Daímon*, the *Res Pública Revista de Historia de las ideas políticas*, which I still edit; I have founded and directed the *Saavedra Fajardo Collection* of the Biblioteca Nueva publishing house, and the *Hestia-Dike Collection* with the Pretextos publishing house. I also currently direct the journal *Anales de Historia de la Filosofía* and I am a member of the editorial board of the *Journal of Spanish Cultural Studies*, as well as many other international journals. The culmination of this internationalization has been the obtaining of funding for the Research Project The Forms of Contemporary Politics: Populism, Nationalism and Republicanism in the Iberoamerican Context (EHP01/2017), from the Ibero-American Union of Universities.
